## Sewing Student Emergency/Release Form

Our goal at Tanners is to provide all of our students with an exemplary sewing education! Your child will be learning in a professional sewing environment with professional equipment such as sewing machines and irons. Use of the equipment is monitored at all times, and proper safety methods are taught without fail. For the safety of your child please review the following policies regarding enrollment. Once you have read the following information. Please sign, date and return the registration form at the first session your child will be participating. Your child will not be able to participate without a signed and dated release form. Tanner's makes no exception to this rule. Materials fee must be paid in cash directly to the instructor at the beginning of the session. Children must bring a snack and wear closed toe shoes. No visitors allowed in class.

1. Only a parent or legal guardian may register their child for kids classes or camps
2. Participation in Tanner's classes and camps is solely the risk and liability of the parent or legal guardian.
3. Due to the potentially dangerous nature of sewing equipment and tools, it is the responsibility of the registering parent or guardian to ensure proper placement of the child with regard to the child's skill level. Tanners and its employees cannot except liability for any injury or damages you or your child may suffer related to premises of Tanners or participation in activities sponsored by Tanners. Every effort will be made by Tanners and its employees to ensure the safety of your child while on the premises of Tanners.
4. If an emergency or illness occurs while your child is on the premises of Tanner's and the Tanner's staff determines that the situation is life threatening or otherwise potentially hazardous to your child, your child's health, other children or any property, we may escort your child from the premises of the building. We may at that time request any staff, governmental or professional assistance deemed necessary to protect the welfare of the child. Every effort will be made to contact the legal guardian first.
5. Tanner's staff may not administer any medication to any child. If the child has a pre-existing condition requiring or a need for prescribed medication, please ensure the parent or guardian is able to satisfy these needs prior to or after the days session.
6. For the welfare of everyone, if your child is sick on a class day, please keep them home.
7. Please make arrangements to arrive no earlier than 10 minutes prior to class time, and retrieve your child at the end of the scheduled class time. Any child left more than 20 minutes after the class has ended will incur a babysitting fee of \$20 per ½ hour.
8. Any personal belongings of the enrolled child ,parent or guardian that enter Tanner's premises remain the sole responsibility of the child, parent or guardian. Tanners will not be responsible for lost, stolen or damaged property or belongings.
9. Reminder of Class Policy – We require pre-payment for all class registrations. All registrations must be made online. No refunds for classes that cannot be attended. Refunds or store credits will be issued in the case that the instructor needs to cancel. If the instructor needs to cancel we will do out best to notify you of cancellation as soon as possible. Make-up classes are provided only in the event the instructor misses a class.
